was adjudicated by this Court in two separate cases, Estate of Lee Mansdorf BP 084500

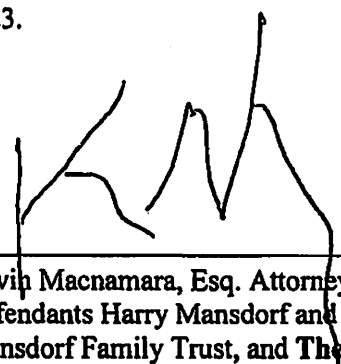

2 The Mansdorf Family Trust respectfully requests that this Court take Judicial Notice of The
3 Order Determining Ownership of Property and Declaration that the Property is Owned by
4 Mansdorf Family Trust Dated August 31, 1967; and Transferring the Property to Said Trust in
5 the case Estate of Lee Mansdorf BP 084500 and the Judgment After Trial By The Court in the
6 case of Mansdorf v. Giacomazza, case number BC385946

7 There is no jurisdiction in this Court to order the sale of The House because it does not
8 belong to Harold Mansdorf. The Judgment in the present case is against Harold Mansdorf, not
9 the Mansdorf Family Trust. Moreover, Harry Mansdorf is not the only beneficiary of the
10 Mansdorf Family Trust and Plaintiffs are seeking to circumvent due process by seeking
11 enforcement against The Mansdorf Family Trust when in reality the judgment is not against
12 The Mansdorf Family Trust. Harry Mansdorf and The Mansdorf Family Trust respectfully
13 requests that this Court take Judicial Notice of Default Judgment in the present case.

14 Harry Mansdorf is an affected party, but was not a party to the action due to the fact that
15 he was not a properly named party. Judgment is in the name of Harold Mansdorf, not Harry
16 Mansdorf. If there is going to be any correction to the name on the judgment, this should
17 Properly be heard before Supervising Judge of the Superior Court since the Judge who heard
18 The matter and who made the judgment is no longer a Judge in the Los Angeles County
19 Superior Court. CCP §473(a) and LASC Local Rule § 2.23.

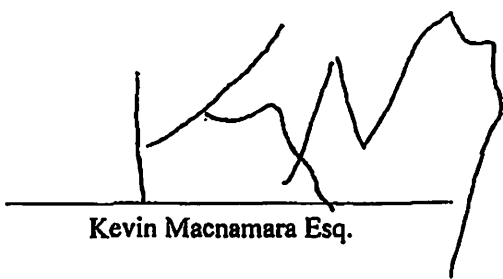
